INQUIRING THE HONORABLE SECRETARY, GUILLERMO CARAGUE, DEPARTMENT OF BUDGET AND MANAGEMENT, MALACANANG, MANILA REGARDING THE GRANTING OF PERSONNEL ECONOMIC RELIEF ASSISTANCE TO GOVERNMENT EMPLOYEES WHO BELONGS TO SALARY GRADE 24 BUT RECEIVED BELOW ₱4,000.00 WITHOUT ALLOANCE AND TO INCREASE INTERNAL REVENUE ALLOTMENT OF THIS MUNICIPALITY

WHEREAS, this Honorable Body, the Sangguniang Bayan is fully aware of the Memorandum Circular issued by the Honorable Secretary, Guillermo Carague of the Department of Budget and Management;

WHEREAS, one of the requisites embodied in the Memorandum Circular is the exemption of employees whose salary is grade 24, ranging from ₱4,000.00 and above;

WHEREAS, Member of Legislative body in this municipality belongs to salary grade 24 but only received ₱3,999.19, without representation allowance;

WHEREAS, standardization of salaries of Municipal employees in this Municipality is only adjusted to 45% increase due to lack of funds;

WHEREAS, increase of Revenue collections cannot be implemented due to Insurgency problem;

WHEREAS, Bulalacao belongs to one of Pro-Poor Municipalities throughout the Philippines hence, financial assistance is indispensable;

NOW, THEREFORE, resolved as it is hereby resolved, to inquire the Honorable Secretary Guillermo Carague of the Department of Budget and Management whether member of Legislative body whose salary is grade 24, no representation allowance and received less than ₱4,000.00 could also avail the Personnel Economic Relief Assistance;


