RESOLUTION CREATING THE POSITIONS OF SOCIAL WELFARE OFFICER III AND SOCIAL WELFARE OFFICER I IN THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO

" WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 transfers the responsibility for the delivery of basic services and facilities from the National Government Agencies concerned to the Local Government Units;

" WHEREAS, the Code stipulates that the transfers of basic services and facilities shall be accompanied by the transfer of the national personnels concerned and assets to ensure continuity in the delivery of such services and facilities;

" WHEREAS, Executive Order No. 503 mandated the LGU to absorb the national government personnels without any diminution in rank and salary grade and that the absorption of NGA personnels by the LGU shall create the equivalent position of the affected personnels;

" WHEREAS, Section 22 of Civil Service Memorandum Circular No. 19 states that the positions absorbed by the local government units from the national government agencies shall be automatically created upon the transfer of their corresponding budgetary allocation;

NOW THEREFORE, be it;

RESOLVED as it is HEREBY RESOLVED to create as it hereby created the positions of Social Welfare Officer III and Social Welfare Officer I in the local government unit of Bulalacao, Oriental Mindoro;

RESOLVED FURTHER, that said created positions shall be under the direct supervision of the Office of the Municipal Mayor as embodied in the newly-approved organizational structure of municipal officials and employees of Bulalacao, Oriental Mindoro;

RESOLVED FINALLY, that copies of this Resolution be furnished the Civil Service Commission Field Office, Calapan, Oriental Mindoro, the Municipal Planning and Development Office, the Municipal Treasurer's Office and the Office of the Municipal Mayor all of Bulalacao, Oriental Mindoro for their information, reference and guidance.
