BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Section 51.01, Article I of the Revised Revenue Code of Bulalacao, Oriental Mindoro, 1992, provision on rental or sale of municipal cemetery lots is hereby amended to read as follows:

" Section 51.01. Imposition of Fees. There shall be collected the following rental fees for a lease of five (5) years.

	<u>RENTAL FEE</u>
1) For each burial lot consisting 5sq.m. (2x2 ½ m) or fraction thereof (including interment) for a period of five (5) years . . . . .	P 50.00
2) For every sq. m. in excess of 5 sq.m. . . . .	5.00
3) For each niche compartments for a period of five (5) years . . . . .	75.00
4) For construction of niche per niche . . . . .	25.00
5) Sale of cemetery per sq. m. but not more than 20 sq.m. . . . .	100.00
