ORDINANCE NO. 0378

AN ORDINANCE REGULATING THE OWNERSHIP AND USE OF CHAINSAW IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

Sponsored by: Hon. Senen C. Familara

BE IT ORDAINED by the Sangguniang Bayan Of Bulalacao, Oriental Mindoro; that:

SECTION 1. No person shall own, keep, buy, possess and use chainsaws in the Municipality of Bulalacao, Oriental Mindoro except those who were granted with necessary permits by the Department of Environment and Natural Resources;

SECTION 2. Any person, whether natural or juridical who has secured permission from the Department of Environment and Natural Resources to own and use chainsaws, shall before operate in the Municipality of Bulalacao, Oriental Mindoro, secure the necessary clearance or permit from the Municipal Mayor;

SECTION 3. Any person who violates any of the provisions of this Ordinance shall be punished by a fine of Two Thousand and Five Hundred Pesos (P2,500.00) or by an imprisonment of six (6) months or both such fine and imprisonment at the discretion of the Court;

SECTION 4. All Ordinances inconsistent hereof are hereby repealed, modified accordingly;

SECTION 5. This Ordinance shall take effect ten (10) days after its publication.
