REVERTING THE AMOUNT OF TWO HUNDRED AND TWENTY THOUSAND PESOS (P 220,000.00) FOR THE CONSTRUCTION OF MUNICIPAL MULTI-PURPOSE HALL FROM THE THREE HUNDRED THOUSAND PESOS (P 300,000.00) FOR THE CONSTRUCTION OF SANGGUNIANG BAYAN SESSION HALL
