SECTION 1. The sum of Two Million Seven Hundred Seven Thousand, Seven Hundred Seventy Six Pesos and Nineteen Centavos (P 2,707,776.19) taken from the Internal Revenue Allotment, Share in real Property Tax, Balance in Barangay Administration fund and Municipal Aid for the Annual Budget of the component Barangays of the municipality of Bulalacag, Oriental Mindoro is hereby approved.
