EARNESTLY REQUESTING THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A FISH PORT AT BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Oriental Mindoro is one part in our country that needs infrastructure support to handle fish catch in order to maximize the harvest that it gets out of its coastal area;

"WHEREAS, there is a need to reduce post harvest losses, improve the quality of produce for domestic and export consumers, enhance monetary returns of small-scale fishermen and to promote efficient packing and processing produce, hence, the necessity to construct a municipal fishing port on this municipality which is traditional fish collection center and transshipment point to urban markets;

"WHEREAS, with the establishment of a fish port, private individuals would be encouraged to put more money on fishing ventures coupled with a systematic revenue collection by the government as a result of the construction of such port, financial resource is bound to increase;

"WHEREAS, the establishment of fish port in this Municipality would certainly redound to the socio-economic benefits of the residents whose primary source of income derives from fishing, Now: therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To earnestly request the Honorable Rodolfo G. Valencia, Provincial Governor to allocate funds for the construction of a fish port at Bulalacao, Oriental Mindoro;
