RESOLVED as it is HEREBY RESOLVED to approve the following Municipal Ordinance:

ORDINANCE NO. 28  
Series of 1993

AN ORDINANCE GRANTING LOYALTY PAY TO THE MUNICIPAL GOVERNMENT OFFICIALS AND EMPLOYEES OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. A loyalty pay shall be given to an employee of the municipal government of Bulalacao, Oriental Mindoro who has completed at least ten (10) years of continuous and satisfactory service;

SECTION 2. The loyalty pay shall not be more than one hundred pesos (P 100.00) per year of service, contingent on the availability of savings. Provided, however, that those who have received the award after the first ten (10) years shall, upon reaching the fifteenth (15th) year, receive only the equivalent to the five years additionally served;

SECTION 3. A loyalty pay shall be premised on continuous and satisfactory service; An unsatisfactory rating or finding of guilt in any administrative case is sufficient ground for not granting the said loyalty pay;

SECTION 4. APPLICABILITY CLAUSE. The grant of loyalty pay shall apply to all officials and employees of the Municipal Government of Bulalacao, Oriental Mindoro;

SECTION 5. PENALTY CLAUSE. Any person found violating this Ordinance shall, upon conviction, be punished by a fine of not more than two thousand five hundred pesos (P2,500.00) or by an imprisonment of not more than six (6) months or both such fine and imprisonment at the discretion of the Court;

SECTION 6. REPEALING CLAUSE. All Ordinances inconsistent hereof are hereby repealed or modified accordingly;

SECTION 7. EFFECTIVITY. This Ordinance shall take effect ten (10) days after its publication;

RESOLVED FURTHER, to submit copies of this Resolution embodying an Ordinance to the Municipal Treasurer, Budget Officer and Personnel Officer, all of Bulalacao Oriental Mindoro, for their information and guidance.
