
ACTIONS TAKEN ON RESOLUTION PASSED BY THE SANGGUNIANG BARAN-  
GAY OF MILAGROSA, BULALACAO, ORIENTAL MINDORO


"WHEREAS, Section 57 and Section 447 par (1i) empower

to be inconsistent with law or municipal ordinances;


"WHEREAS, the following legislative measures of the Sang-

thereon:






