" RESOLUTION NO. 95-08-043-B-027

EARNESTLY REQUESTING THE HONORABLE SANGGUNIANG PANGALAWIGAN, CALAPAN, ORIENTAL MINDORO, TO EXTEND MEDICAL ASSISTANCE TO THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO BY ALLOCATING MEDICINES FOR THE INDIGENT RESIDENTS OF THIS TOWN

"WHEREAS, under Section 15, Article 11, the Constitution recognizes the right to health, key concepts of which are integrated, comprehensive and affordable health services, premised on the understanding that the high level of health of a people and of a country can be achieved only through a combination of social, economic, political and cultural conditions;

"WHEREAS, it is noted, that although the right to health should be enjoyed of all, Sections 11-13, Article XIII of the Constitution express a clear bias for the underprivileged;

"WHEREAS, Bulalacao, Oriental Mindoro is among those low income municipalities with a health center run by one physician, one nurse, one medical technologist and a small number of midwives making them incapable of accomodating all that need their services;

"WHEREAS, this shortage in manpower coupled with inadequate health facilities and insufficiency of medicines magnified the already sad state of health in this municipality;

"WHEREAS, Bulalacao, Oriental Mindoro is one of those classified as Pro-Poor Municipalities under Executive Order Numbered 370;

"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro, cognizant of the welfare of its under-privileged constituents who need proper care and medical assistance wishes to ask for support from the higher authorities; Now therefore, be it;

RESOLVED, AS IT IS HEREBY RESOLVED, To earnestly request the Honorable Pedrito A. Reyes, Vice Governor and Members, Sangguniang Panlalawigan, to extend medical assistance to the Municipality of Bulalacao, Oriental Mindoro by allocating medicines for the indigent residents of this town;


