REQUESTING THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) THROUGH ITS NEW CHAIRMAN TO PLEASE GRANT ONE OF THE FOUR UNRELEASED MOBILE CLINICS IN FAVOR OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro has a very scarce medical personnels to handle the ever growing population both in the lowland, the uplands (largely populated by Hanunuo-Mangyans) and the island barangays;

“WHEREAS, the lack of basic medical facilities is also a major setback in promoting health in the locality, that one has to go to Calapan City (about 180 kms. away) just to get an x-ray examination;

“WHEREAS, it is learned that PAGCOR has four unreleased mobile clinics with built-in and available medical equipments;

“WHEREAS, the grant of such mobile clinic shall be of great assistance to the inhabitants of this Municipality whose more than 70% live under the poverty line and endure poor access to hospitals either due to poverty or lack of accessibility; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Philippine Amusement and Gaming Corporation (PAGCOR) through its new Chairman to please grant one of the four unreleased Mobile Clinics in favor of the Municipality of Bulalacao, Province of Oriental Mindoro;


