*EARNESTLY REQUESTING THE HONORABLE THADDEUS VENTURANZA, PROVINCIAL VICE GOVERNOR AND PRESIDING OFFICER, SANGGUNIANG PANLALAWIGAN TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF TWO UNITS 3-CLASSROOM BUILDINGS FOR MAUJAO NATIONAL HIGH SCHOOL AT BARANGAY MAUJAO AND SAN ROQUE NATIONAL HIGH SCHOOL AT BARANGAY SAN ROQUE BOTH AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO*

*"WHEREAS, Section 17, Article II of the Constitution provides that the State shall give priority to education, arts, welfare and sports to foster patriotism and nationalism to accelerate social progress and promote total human liberation and development;*

*"WHEREAS, the opening of Maujao National High School at Barangay Maujao, this Municipality this SY-2001-2002 was made through the initiative of the Local Government Unit of Bulalacao in an effort to make secondary education accessible to the students coming from Barangay Maujao and its four (4) adjacent barangays;*

*"WHEREAS, due to financial constraints, the Municipal Government could not readily provide the newly opened secondary school with all the school facilities and amenities, and more importantly the provision of additional classroom building for the possible increase of enrollees next school year;*


*"WHEREAS, with the same reason of boosting literacy among the far-flung barangays such as that of San Roque and San Juan, there is a proposal of establishing another secondary school at the area that the construction of one unit 3-classroom building is direly needed to facilitate its immediate opening;*
