" RESOLUTION NO. 00-04-066

RESOLUTION PETITIONING THE ALLEGED REPORT OF INVESTIGATION CONDUCTED BY DENR-MINES AND GEOSCIENCE BUREAU, REGION VI, PUTTING THE ISLAND OF LIWAGAO WITHIN THE JURISDICTION OF THE PROVINCE OF ANTIQUE, WHICH IS CONTRARY TO THE PROVISIONS OF PRESIDENTIAL PROCLAMATION NUMBERED 1801

"WHEREAS, the DENR-Mines and Geoscience Bureau, Region VI, submitted a Report indicating that the Island of Liwagao belongs to the Municipality of Caluya, Antique where in fact it legally and historically belongs to Bulalacao, Oriental Mindoro;

"WHEREAS, such an act by DENR constitutes violation of the rights of the Province of Oriental Mindoro, more particularly that of the Municipality of Bulalacao who exercised jurisdictional authority since time immemorial over the subject contested island;

"WHEREAS, it is incumbent for the present Administration to protest all documents putting the Island of Liwagao into the jurisdiction of Antique, knowing that electoral records and land tax declarations point out Bulalacao, Oriental Mindoro as a situs of their governmental obligations;


