**RESOLUTION NO. 02-10-210**

**REQUESTING THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE, SAN MARIANO, ROXAS, ORIENTAL MINDORO TO STOP ISSUING PERMITS TO CHARCOAL MANUFACTURERS AND SHIPPERS OF THE MUNICIPALITY OF BULALACAO IN COMPLIANCE TO THE MEMORANDUM ISSUED BY THE PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE DATED OCTOBER 2, 2002**

**"WHEREAS**, on October 2, 2002, Mr. Juan C. de la Cruz, Provincial Environment and Natural Resources Officer (PENRO) issued a Memorandum directing the Community Environment and Natural Resources Officer (CENRO), San Mariano, Roxas, Oriental Mindoro to totally stop the issuance of shipping documents and all other related permits allowing the transport of charcoal manufactured out of wood or trees;

**"WHEREAS**, the Memorandum cited above provides relief to the concerned officials and residents of the Municipality of Bulalacao who lost their hope on their attempt to stop the continuous and rampant charcoal making, feeling afraid of possible legal consequences that might arise in the future;

**"WHEREAS**, this fear was exemplified on October 20, 2002 wherein a large volume of sacks of charcoal owned and about to be shipped out by a certain Edmundo Barcelona was intercepted by the PNP operatives of Bulalacao Station; to much dismay of the government, Mr. Barcelona was able to show necessary documents and written permission issued by the CENRO making the business of Mr. Barcelona a legal one, it will be worthy of questioning why despite of the issued Memorandum from the higher up the profiteers in their legal charcoal making activities were to invoke the permission issued by the PENRO which by operation of law had already been rescinded by the virtue of memorandum mentioned above;











