A RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL MAYOR TO REPRESENT THE MUNICIPAL GOVERNMENT IN ENTERING INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) THRU ITS PROVINCIAL DIRECTOR FOR THE IMPLEMENTATION OF THE FOOD ALWAYS IN THE HOME (FAITH) PROGRAM IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, the Department of the Interior and Local Government is implementing one of its flagship programs known as the Food Always in the Home (FAITH) Programs pursuant to the call of President Arroyo to direct resources of the government to address the problem of poverty in the country;

“WHEREAS, the FAITH program shall be implemented to ensure food security in the homes, promote sustainable agricultural farm practices and enable beneficiaries to earn additional income;

“WHEREAS, the Local Government Unit is mandated to provide extension and on site services and facilities related to agriculture and fishery activities which include dispersal of livestock and poultry, fingerlings, and other seeding materials for aquaculture, palay, corn and vegetable seeds, among others;


“WHEREAS, the Local Government Unit is also mandated to provide livelihood and other pro-poor projects for its constituents; Now, therefore, be it


