RESOLUTION NO. 03-07-121

REQUESTING NAMRIA THROUGH ENGR. ENRIQUE A. MACASPAC, CGSD, NAMRIA TO VALIDATE THE DELINEATED MUNICIPAL WATER OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, within the realm of Section 5 of DENR Administrative Order No. 201-17, request for delineation and delimitation of municipal waters shall be directed to the Administrative of the NAMRIA, so as the Director of the Coast and Geodetic survey Department through a request by the Sangguniang Bayan or a resolution by the Sangguniang Panlalawigan in whole of the Province of its coastal municipalities;

"WHEREAS, the Island of Liwagao historically belongs to the Municipality of Bulalacao and within the 15 kilometers distance a certain municipality could claim jurisdiction in fact, previous map of NAMRIA pointed out that Liwagao belongs to the Municipality of Bulalacao, oriental Mindoro as could be attested by their realty taxes paid and electoral practices done in this Municipality;

"WHEREAS, in asserting the police power of this this Municipality, the Municipal government indicted certain persons allegedly and regularly conducting palpable acts of illegal fishing as well as illegal quarrying within the Island presumed to the part and parcel of the territorial jurisdiction of the Municipality of Bulalacao, Province of Oriental Mindoro, absurdly for a known reason the Regional Trial court Prosecutors Office failed to file a case against the perpetrators and lamentably the case was thrown back against the accuses on account of technicalities;

ambiguity of the territorial boundaries which it rightly claims and reclaims as its own territory;

"WHEREAS, public hearings have been made and the elders attested as well as the former Mayor, Oscar Lim attested to the fact that indeed, Liwagao Island belongs to the Municipality of Bulalacao, Province of Oriental Mindoro;

"WHEREAS, reiterating Section 1 of DENR Administrative Order No. 201, the Municipal Government whereby "verbatim" as follows:

Section 1. Basic Policy:

It is the policy of the State to protect the rights of the people, especially the local communities with priority to marginal fisherfolks, in the preferential use of the municipal waters. The delineation/delimitation of municipal waters will define the geographical extent of the city or municipality's taxation or revenue-generating powers, its law enforcement jurisdiction, resource allocation and general management powers; Now, therefore be it

RESOLVED AS IT IS HEREBY RESOLVED: To: Request NAMRIA through Engr. Enrique A. Macaspac, CGSD, NAMRIA to validate the delineated municipal waters of Bulalacao, Province of Oriental Mindoro;
