**ENDORING TO THE SHELL PHILIPPINES EXPLORATION THROUGH THE
PILIPINAS SHELL FOUNDATION THE INTEGRATED DEVELOPMENT
PROGRAM FOR FISHERFOLKS IN THE MUNICIPALITY OF BULALACAO,
PROVINCE OF ORIENTAL MINDORO**

WHEREAS, the discovery of the natural gas reserves in Palawan by the Shell Philippines Exploration causes the construction and operation of an offshore pipeline off the coast of the province of oriental Mindoro more particularly in the Municipality of Bulalacao;

WHEREAS, believing that the development of such indigenous natural gas resources is essential to the long term stability of fuel and energy prices, as well as to national security and competitiveness, the Province of oriental Mindoro is willing to coordinate and cooperate with the Shell Philippines Exploration to ensure that the project is implemented with proper regard to health, safety and the environment;

WHEREAS, In view of the Implementation of project, the Shell Philippines Exploration will allocate the amount of One Million US Dollars (US \$1,000,000.00) to finance sustainable development projects for Oriental Mindoro in partnership with the Province and shall be likewise distributed to different Municipalities affected by the laying of pipelines such as that of the Municipality of Bulalacao through the Integrated Development Program for fisherfolks (IDPF);

WHEREAS, the IDPF is comprehensively prepared according to the priority needs of the people and the community as patterned to the strategies of the Social Reform Agenda-Minimum Basic Needs Approach which aimed to improve the quality of life of poor or the disadvantaged sectors particularly those marginal fishermen in the coastal barangays of Bulalacao, Oriental Mindoro;

WHEREAS, the Integrated Development Program for Fisherfolks of this Municipality is believed to empower the fisherfolk families and communities through active participation and involvement which could uplift their socio-economic condition; Now, therefore, be it
