RESOLUTION NO. 04-08-102

EARNESTLY REQUESTING THE PHILIPPINE COCONUT AUTHORITY, REGION IV TO ALLOCATE FUNDS FOR THE PURCHASE OF COCONUT SEEDLINGS TO BE DISTRIBUTED TO MARGINAL FARMERS OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 17 of Republic Act 7160, otherwise known as the Local Government Code of 1991 known as extension and on-site research services and facilities related to agriculture which include dispersal of seedling materials for aqua-culture, palay, corn, vegetables seed farms, fruit tree, coconuts and other kinds of seedlings nurseries the demonstration farms; quality control of copra preferably through cooperative; inter-barangay irrigation system; water and soil utilization and conservation projects; and enforcement of fishery laws in Municipal waters including the conservation of mangroves;

"WHEREAS, such municipal agricultural powers were conceived that a Municipality may now deliver certain agricultural and physi-cultural services that extension work and on-site research services, which of use includes the distribution of materials such as seedlings;

"WHEREAS, in this connection the Municipality of Bulalacao, Province of Oriental Mindoro ought to insist if not, request that continuing other education and actual implementation about the beauty, richness and value of coconut industry in the country shall be of immense and direct contributory factor to the progress of our nation;

"WHEREAS, it used to be a program of Philippine Coconut Authority that the dispersal of coconut seedlings as one of the services that it believes the Municipality can deliver; and the principles was valuable project. The program however in the words of Senator Aquilino Pimentel was used either to cater the

duplicity of certain bureaucrats or to promote the political aspiration of certain people in high places in government so that only those province got the price;

"WHEREAS, recognizing the minimal copra production of our country which is one prime commodities among consumer as well as an export product; the seriousness of a human and environmental impact arising from the lack of strategic approach to encourage and promote our copra production was highlighted by the primitive grower of several coconut haciendas and this Municipality which is duty bound to manage in these areas of jurisdiction this kind of problem is now resorting to seek the intervention of the National Government which if granted would be directly assimilated to protect our local service unit; Now, therefore, be it . . .

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Philippine Coconut Authority, Region IV to allocate funds for the purchase of coconut seedlings to be distributed to marginal farmers of Bulalacao, Province of Oriental Mindoro;


