EARNESTLY REQUESTING THE HONORABLE LUISA EJERCITO-ESTRADA, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF A DORMITORY TO BE USED BY THE TRIBAL COMMUNITY MEMBERS ENROLLED IN BULALACAO NATIONAL HIGH SCHOOL, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is composed of fifteen (15) barangays separated by sea waters and high mountain ranges making it difficult to reach due to the absence of a good communication and transportation systems;

"WHEREAS, it is observed that students belonging to the Tribal Community who are enrolled in the Bulalacao National High School, the only secondary school in the whole municipality find difficulties in looking for a house for their temporary use during school days considering that they could not go home everyday due to geographical situation;

"WHEREAS, it should be to the best interests of these minority students if a dormitory inside the school campus be provided for them;

"WHEREAS, being the Pro-Poor Municipality with limited funds, the abovementioned project could only be realized through the benevolence of the good senator; Now, therefore, be it


