"WHEREAS, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, Section 2 (i) Extension and on-site research services and facilities related to agriculture and fishery activities which include dispersal of livestock and poultry, fingerlings, and other seedling materials for aquaculture; palay, corn, and vegetable seed farms; medicinal plant gardens, fruit tree, coconut, and other kinds of seedling nurseries; demonstrations farms; quality control of copra and improvement and development of local distribution channels, preferably through cooperatives;

"WHEREAS, Bulalacao is a 3<sup>rd</sup> class municipality with a vast agricultural land, has 15 barangays and with a total agricultural land area of 10, 325.80 hectares where 6,016 individuals are employed in the agricultural sector and has a tropical climate type conducive to planting of staple crops such as rice, corn, onion including garlics, coconuts and other varieties of vegetables and fruits transported to Manila and nearby provinces;
