EARNESTLY REQUESTING THE HONORABLE ARNAN C. PANALIGAN, PROVINCIAL GOVERNOR AND CHAIRMAN OF THE PROVINCIAL SCHOOL BOARD TO FACILITATE THE ALLOCATION OF NEW TEACHING ITEM POSITIONS FOR THE BULALACAO NATIONAL HIGH SCHOOL MAUJAO, SAN ROQUE AND BENLI EXTENSION CLASSES AT THE MUNICIPALITY OF BULALACAO, THIS PROVINCE

“WHEREAS, it is a Constitutional mandate that the State shall assign the highest budgetary, priority to education and that basic and quality education be made accessible to all;

“WHEREAS, the Bulalacao National High School San Roque, Maujao and Benli Extension Classes which cater first to fourth year students were established several years now through the initiative of the Local Government Unit of Bulalacao allocating a huge amount of money to pay the salaries and wages of teachers assigned thereat which is a big burden on the coffer of this Fourth Class Municipality;

“WHEREAS, it is glad to note that the Department of Education has done its part by allocating several new teaching item positions for the secondary schools mentioned above that additional items shall be highly appreciated to lessen the financial burden of this Municipality and instead use this educational fund for its developmental projects;
