NATIONAL HIGHWAY FROM BARANGAY BAGONG SIKAT PROPER TO SITIO CAMBAYANG, BARANGAY CABUGAO, BOTH SITUATED AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS,** it shall be highly recognized if the abovementioned program be realized through the assistance of the good Senator; Now, therefore, be it


