**EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO EXTEND FINANCIAL ASSISTANCE TO THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO WHICH WAS BADLY DAMAGED BY TYPHOON SENYANG**

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro suffered extreme and various losses in agricultural produce, livestock and fishing industries and other related damages caused by Typhoon Senyang on December 10, 2006 which brought distress, hunger and misfortune among its people;

"WHEREAS, it was also noted that transportation and communication facilities were heavily damaged, houses and other building structures were destroyed which resulted to social and economic turmoil for both the Municipal Government and its constituents;

"WHEREAS, the Sangguniang Bayan of Bulalacao, Oriental Mindoro declared this Municipality under the State of Calamity in order to restore the normal living conditions of the affected community through the disbursements of its 5% Calamity Fund however, such fund was already exhausted that there is a need to augment it particularly coming from the national government; Now, therefore, be it
