AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ANY PRIVATE ENTITY OR INDIVIDUAL WHO ARE BONAFIDE RESIDENTS OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN THE GRANT OF THE OPERATION AND MANAGEMENT OF THE IODIZED SALTBED FARM PROJECT SITUATED AT SITIO BANGKAL, BARANGAY SAN JUAN, THIS MUNICIPALITY

"WHEREAS, it is a Constitutional mandate that the State shall recognize the indispensable role of the private sector, encourages private enterprise and provide incentives to needed investments;


"WHEREAS, the Municipal Government of Bulalacao is ready to grant the operation and management of the Iodized Saltbed Farm Project to any interested and qualified groups or individual in cooperation with the barangay officials of San Juan whose task is to monitor the implementation of the said project;


"WHEREAS, it is understood that the grantee should follow the terms and conditions that may be formulated by the Municipal government particularly its 10% share from the gross income while 50% will go to the barangay concerned; Now, therefore, be it


