## RESOLUTION NO. 10-08-061

REQUESTING DIRECTOR MALCOLM I. SARMIENTO, REGIONAL DIRECTOR, BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR), REGIONAL OFFICE TO ALLOCATE THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (PHP500,000.00) TO BE USED FOR THE CONSTRUCTION OF A BUILDING TO BE REFERRED TO AS BANTAY DAGAT CONTROL AND SUPERVISION HEADQUARTER AT THE ISLAND OF SILAD, BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO

**"WHEREAS,** fishing industry and the preservation of the remaining aqua-marine resources of this Municipality are the present thrust of this Administration;

**"WHEREAS,** the rampancy of several methods of illegal fishing compromised our effort to alleviate poverty and at the same time a strategy to fight ecological imbalance;

**"WHEREAS,** poisonous cyanide fishing destroys our corral reefs and blasting dynamite fishing kills even the next generation of fishes of different species both having destroy our environment and ecology which serves corral reefs as their habitats and future aqua-marine living things;

**"WHEREAS,** this Administration so desires that an establishment of a center be put-up in the Island of Silad, Barangay Milagrosa, Bulalacao, Oriental Mindoro which may call as Bantay Dagat Control and Supervision Headquarter;

**"WHEREAS,** Silad Island is in a vantage point wherein fishing activities could be monitored either legal or illegal by authorities that shall be stationed in that area; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request Director Malcolm I. Sarmiento, Regional Director, Bureau of Fisheries and Aquatic Resources (BFAR), Regional Office to allocate the amount of Five Hundred Thousand Pesos (Php500,000.00) to be used for the construction of a Building to be referred to as Bantay Dagat Control and Supervision Headquarter at the Island of Silad, Barangay Milagrosa, Bulalacao, Oriental Mindoro;
