BALTAZAR, JR., REGIONAL DIRECTOR, LAND TRANSPORTATION OFFICE (LTO), REGION IV-B, MIMAROPA FOR THE ESTABLISHMENT OF AN EXTENSION OFFICE OF THE LTO IN ROXAS, ORIENTAL MINDORO

"WHEREAS, it has been an oft-repeated request of the second district of the Province of Oriental Mindoro, particularly the Municipality of Bulalacao that a Sub-Office of the Land Transportation Office (LTO) be established in the Municipality of Roxas, Oriental Mindoro to serve applicants for driver's license including that of the registration of vehicles and all transactions/requirements necessitating LTO's approval;

"WHEREAS, it is the pleasure of this Sanggunian to protect and look after the welfare of its constituents to afford unto them the convenient way in their transactions with the LTO in particular considering the proximity of the distance between the Municipality of Bulalacao to Roxas which is only 45 kms., while Calapan City, 186 kilometers away is a considerable distance to be reckoned if distance and accessibility are factors that are to be seriously considered;

"WHEREAS, the establishment of the LTO Sub-Office in Roxas, Oriental Mindoro would definitely benefit the residents herein for registration of their vehicles and processing and release of their driver's licenses be made easier and economical; Now, therefore, be it;






