RESOLVED AS IT IS HEREBY RESOLVED, To: Set the date of the public auction for the exclusive fishery rights on February 3, 2009 at 2:00 o'clock p.m., in case of failure, the second and final bidding is hereby likewise set to be held ten (10) days thereafter;

Zone I - From Culasi point to Buyayao point	-	Php 20,000.00
Zone II - From Buyayao point to Binanawang point	-	50,000.00
Zone III - From Maasin point to Loboc point including the Kaburayan River	-	Not for bidding Declared as Fish Sanctuary
Zone IV - From Kaburayan River to Tambi-Tambi point	-	40,000.00
Zone V - From Tambi-Tambi point to Mangusing point	-	50,000.00
Zone VI - From Mangusing point to Burungcaan point	-	40,000.00


