RESOLUTION NO. 21-06-197

EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THRU SECRETARY WENDEL AVISADO TO ALLOCATE THE NECESSARY AMOUNT TO BE USED FOR THE OPENING AND CONCRETING OF SEVERAL LOCAL ACCESS ROADS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao is a Pro-Poor Municipality pursuant to Executive Order No. 370 being it, Bulalacao is now emerging into a tourism hub of the Province of Oriental Mindoro because of its rich cultural heritage, beautiful islands and islets with long and powdery white sand beaches, rich marine life resources where everyone could enjoy eating fresh varieties of marine products and wide range of forest resources best for trekking and where everyone could have a chance to have a personal encounter with our hanunuo mangyan brothers and sisters living in the hinterland;

"WHEREAS, tourism has become an important factor that has an impact on development because it generates income and employment however, the ability to benefit from tourism industry depends on the availability of investments needed to develop the necessary infrastructures particularly access roads to facilitate comfort and convenience of incoming tourists;

"WHEREAS, pursuant to Local Budget Circular No. 131, dated January 8, 2021 under Special Provision No. 3 of the Local Government Support Fund-Financial Assistance (LGSF-FA) to Local Government Units in R.A. 11518 or the FY 2021 General Appropriations Act, the appropriated amount of PhP 13B shall be used for financial assistance to LGUs giving priority to infrastructure

projects consistent with Build, Build, Build Program of the National Government. The following local access roads were identified by the LGU-Bulalacao to be of utmost priority; to wit:

- i. Opening and Concreting of Tagwak-Cogon Malapad Local Access Road PhP 50M
- ii. Opening and Concreting of Dakutan-Kapulawan-Balatasan Proper Local Access Road 95M
- iii. Concreting of San Isidro Proper-San Francisco Local Access Road 79,999,181.82
- iv. Opening and Concreting of Bagong Sikat-Lambok Local Access Road 90M
- v. Opening and Concreting of Umabang-Bailan Local Access Road 95M
- vi. Opening and Concreting of Benli Proper to Bailan Local Access Road 95M
- vii. Opening and Concreting of F.F. Cruz to Umabang Local Access Road 90M
- viii. Opening and Concreting of Diversion Road to San Miguel Local Access Road 95M
