### RESOLUTION NO. 22-11-578

**AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE LOCAL GOVERNMENT OF BULALACAO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DANGEROUS DRUGS AND BOARD FOR THE IMPLEMENTATION IN THE MUNICIPALITY OF BULALACAO, REPUBLIC ACT NO. 9165 KNOWN AS THE COMPREHENSIVE DANGEROUS DRUGS ACT OF 2002 AS AMENDED, "TO EXTEND ASSISTANCE IN THE ESTABLISHMENT AND MAINTENANCE OF TREATMENT AND REHABILITATION CENTERS IN THE COUNTRY" AND SUCH OTHER TERMS AND CONDITIONS AS MAY BE AGREED UPON BY BOTH PARTIES**

**WHEREAS**, the Dangerous Drugs and Board is the policy making and strategy-formulating body in the planning and formulation of policies and programs on drug prevention and control and is tasked to develop and adopt a comprehensive, integrated, unified and balanced national drug abuse prevention and control strategy;

**WHEREAS**, the Dangerous Drugs and Board formulated the Philippine Anti-Illegal Drugs Strategy ("PADS") which outlines the balanced effort of the government to strengthen its campaign against abuse and trafficking of illegal drugs and precursors, which was adopted by the Office of the President for institutionalization and implementation in all government offices and local government units pursuant to Executive Order No. 66, series of 2018;

**WHEREAS**, the Dangerous Drugs and Board is mandated by Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002 (the "Act") as amended to extend assistance in the establishment and maintenance of treatment and rehabilitation centers in the country;

**WHEREAS**, to pursue the objective of the Act and the provisions of the PADS, the parties recognize the importance of working together to successfully implement the evidence-based treatment and rehabilitation programs of the government and addressed problems of drug use and dependence in the community;

**WHEREAS**, the Municipality of Bulalacao, Oriental Mindoro manifested its intention to implement a community-based treatment and rehabilitation program in its jurisdiction to support the campaign of the government against illegal drug trafficking and abuse;

**WHEREAS**, the Sangguniang Bayan of Bulalacao finding the subject Memorandum of Agreement to be in order deemed it best to approve the same; **Now, therefore, be it**

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Authorize the Municipal Mayor, Engr. Ernilo C. Villas to represent the Local Government Unit of Bulalacao to enter into a Memorandum of Agreement with the Dangerous Drugs and Board for the implementation in the Municipality of Bulalacao, Republic Act No. 9165 known as the Comprehensive Dangerous Drugs Act of 2002 as amended, "to extend assistance in the establishment and maintenance of treatment and rehabilitation centers in the country" and such other terms and condition as may be agreed upon by both parties;


**RESOLVED FURTHER, That:** Any change or alteration in the Memorandum of Agreement originally presented shall have no effect and therefore null and void;


