RESOLUTION REQUESTING THE DEPARTMENT OF TOURISM (DOT) UNDER TOURISM ROAD INFRASTRUCTURE PROJECT PRIORITIZATION CRITERIA (TRIPPC) TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF ACCESS ROADS FROM THE NATIONAL HIGHWAY TO SITIO COROCORO AND ALONG THE COASTLINE OF BARANGAY SAN FRANCISCO, BULALACAO, ORIENTAL MINDORO

“WHEREAS, the Municipality of Bulalacao is on its way to being an agro-eco-tourism destination in the Province of Oriental Mindoro that collaborative hard works from both government and private sectors are applied and gathered together to deliver the best positive outcome;
