RESOLUTION NO. 15-02-032

RESOLUTION EARNESTLY REQUESTING THE HONORABLE REYNALDO V. UMALI, CONGRESSMAN, DISTRICT-II, ORIENTAL MINDORO; CHAIRPERSON, HOUSE COMMITTEE ON ENERGY TO SUPPORT THE SOLAR ENERGY DEVELOPMENT PROJECT PROPOSED BY BRITO ENERGY AND POWER CORPORATION AND BY OTHER CORPORATIONS THAT WOULD DEVELOP ALTERNATIVE OR RENEWABLE ENERGY SOURCE WITHIN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

“WHEREAS, the Sangguniang Bayan of Bulalacao passed Resolution No. 14-07-127 entitled “Earnestly requesting the Oriental Mindoro Electric Cooperative (ORMECO) through Its Board President, Mr. Audel Arago to favorably consider the establishment of a power plant using alternative or renewable source in the Municipality of Bulalacao, Oriental Mindoro”;

“WHEREAS, the same legislative body also passed Resolution No. 14-09-154 entitled “Earnestly Requesting The Oriental Mindoro Electric Cooperative (ORMECO) at Sta. Isabel, Calapan City, through Its Board President, Mr. Audel Arago, to kindly facilitate the construction and/or establishment of the ORMECO Board – Approved Solar Energy Station at Barangay San Roque, Bulalacao, Oriental Mindoro and to favorably consider increasing its proposed load capacity from 1 MW to 2 MW”;

“WHEREAS, the Local Government Unit of Bulalacao has been very consistent in encouraging partners to put up alternative energy source investments here in Bulalacao as it acknowledges the service of electricity as an important tool in steering economic growth towards the achievement of lasting peace and for the general welfare of its constituents;

"WHEREAS, the present status of power and energy in Bulalacao characterized by frequent interruption and shortage, hampers economic activities and discourages business and investments, and hence a great blow against the attainment of the vision "Beautiful and Bountiful Bulalacao" which supports the positioning of Region IV-B (MIMAROPA) to become a prime tourism destination and major supplier of agricultural and fishery products in the country;

"WHEREAS, the presence of Brito Energy and Power Corporation with its interest, experience, and integrity in relation with solar energy development is a significant support to the Rural Electrification Project of the national government and is bringing hope and inspiration to the people of Bulalacao while confronting the challenges of poverty and climate change;

"WHEREAS, the Local Government Unit of Bulalacao expresses its unwavering support to the solar energy development project being proposed and advocated by Brito Energy and Power Corporation or to any alternative or renewable energy development initiative to be undertaken in this Municipality; Now, therefore, be it;

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Reynaldo V. Umali, Congressman, District-II, Oriental Mindoro; Chairperson, House Committee on Energy to support the solar energy development project proposed by Brito Energy and Power Corporation and by other corporations that would develop alternative or renewable energy source within the Municipality of Bulalacao, Oriental Mindoro;






