RESOLUTION NO. 21-06-171

EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO FACILITATE THE CLASSIFICATION OF CAVILLIAN, CORING-OT, MAUJAO, AND CAWACAT RIVERS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AS MAJOR TRIBUTARIES TO RIVER BASINS HENCE, APPROPRIATION OF FUNDS TO CONSTRUCT RIVER FLOOD PROTECTION DIKES AND DREDGING SHOULD BE GIVEN PRIORITY

"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

"WHEREAS, the Municipality of Bulalacao is well-nigh to being an agro-tourism destination in MIMAROPA Region, has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, according to the research of the University of the Philippines Training Center for Applied Geodesy and Photogrammetry (UP-TCAGP) the Municipality of Bulalacao has a 83,100-hectare river basin that covers Barangays Bagong Sikat, Benli, Cambunang, Campaasan, Nasucob, Poblacion and San Juan, it is situated in the southeast point of the Island of Mindoro and northwest of Bulalacao Bay and Tablas Strait, and as per DENR-River Basin Control Office it has an approximate land area of 6,461.35 with estimated run-off of 120 mcm;

"WHEREAS, there are four (4) major rivers in the Municipality of Bulalacao, Oriental Mindoro that are tributaries to a river basin that needs to be dredged in order to maintain its depth and protect its river banks to facilitate the flow of water into a river basin for various purposes, thus appropriation of funds for the construction of river flood protection dikes and its dredging is very much needed;

"WHEREAS, this matter has been already requested before under Resolution No. 20-05-270 and was sent back with a letter from DPWH Regional Office No. IV-B dated November 2, 2020 for the confirmation of which agency or department this shall fall;

"WHEREAS, the inquiry has been answered by a letter from DENR-MIMAROPA Region dated November 25, 2020 informing that this concern must be coordinated to DPWH and should also refer to Environmental Management Bureau (EMB) to determine the classification of the rivers; Now, therefore be it....

RESOLVED AS IT IS HEREBY RESOLVED To: Earnestly request the Department of Public Works and Highways to facilitate the classification of Cavillian, Coring-ot, Maujao, and Cawakat Rivers in the Municipality of Bulalacao, Province of Oriental Mindoro as major tributaries to river basins hence, appropriation of funds to construct river flood protection dikes and dredging should be given priority;
