RESOLUTION NO. 21-05-168

RESOLUTION REQUESTING THE DEPARTMENT OF ENERGY THRU NATIONAL ELECTRIFICATION ADMINISTRATION TO FACILITATE THE APPROPRIATION OR INCLUSION OF FUNDS FOR THE TRANSFER OR RELOCATION OF ELECTRICAL OR TELECOMMUNICATION POSTS TO IDEAL OR STANDARD ROADSIDE MEASURES PRIOR TO OR SIMULTANEOUS WITH THE IMPLEMENTATION OF ROAD-WIDENING PROJECTS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

“WHEREAS, the Department of Energy is the executive department of the Philippine government responsible for preparing, integrating, manipulating, organizing, coordinating, supervising and controlling all plans, programs, projects and activities of the Government relative to energy exploration, development, utilization, distribution and conservation;

“WHEREAS, Bulalacao, Oriental Mindoro is well-nigh to being an eco-agro-tourism destination in MIMAROPA Region, has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

WHEREAS, the progressive take of this municipality in terms of public works and infrastructures is very evident, the road-widening projects are indeed beneficial to its people and undeniably conveys them the awareness of economic development, however it has been escalated that upon the completion of the construction of these projects there are electrical and/or telecommunication posts that have been remained and abandoned on the streets that cause bothersome and even accidents to both the pedestrians and vehicles alike;

"WHEREAS, the Local Government Unit of this Municipality firmly suggests that these electrical or telecommunication posts should be transferred or relocated to ideal or standard roadside measures prior to or simultaneous with the implementation of road-widening projects, thus it would be needing funds to support and fulfill this operation;






