RESOLUTION NO. 20-11-454

EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT THRU SECRETARY WENDEL AVISADO TO ALLOCATE THE AMOUNT OF FIFTEEN MILLION PESOS (PhP15,000,000.00) TO BE USED FOR THE CONCRETING OF SITIO BANTI-GATOL TO AGONG LOCAL ACCESS ROAD SITUATED IN BARANGAY SAN ROQUE, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, the Municipality of Bulalacao is on its way to being an agro-eco-tourism destination in the Province of Oriental Mindoro that collaborative hard works from both government and private sectors are applied and gathered together to deliver the best positive outcome;

“WHEREAS, roadways serve a vital purpose in any places, it allows people and vehicles to traverse a diverse range of lands so that they can reach their destination without any hindrance and it is an important form of infrastructure that is ideal and necessary in the areas;

“WHEREAS, Sitio Banti, Gatol and Agong in Barangay San Roque are homes to Hanunuo Mangyans that the present Administration joined efforts and resources to provide them necessary infrastructural facilities such as a functional transportation and communication systems that shall promote livelihood, enhance social and economic upliftment to boost their moral by giving them enough opportunities to become active and productive members of the community;

“WHEREAS, most part of the roadways in Sitios Banti, Gatol, and Agong all of Barangay San Roque were being destructed by typhoons occurred in the municipality such as Typhoon Tisoy, Ursula, Quinta, Rolly and Ulysses that there is apparent need of reconstruction and refinement;




