**RESOLUTION SUPPORTING ALL THE PROJECTS AND PROGRAMS OF
THE NATIONAL TASK FORCE TO END LOCAL COMMUNIST ARMED
CONFLICT (NTF-ELCAC) IN THE MUNICIPALITY OF BULALACAO,
PROVINCE OF ORIENTAL MINDORO**

“WHEREAS, Article II of the 1987 Constitution provides that the Philippines renounces war as an instrument of national policy. The maintenance of peace and order, the protection of life, liberty and property and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy. The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

“WHEREAS, Executive Order No. 16, s. 2017 adopted the National Security Policy 2017-2022 which calls for the end of all armed threats in the Philippines and recognizes that interval social-political stability rests upon heading the rights that divide the nation by promoting participatory government, synergy of government development efforts and enhancing the participation and responsibilities of local government units (LGU's);

“WHEREAS, in order to effectively address the Communist Terrorist Group (CTG) problem, the government has entered into a massive campaign to spur the development of the rural countryside so that barangays impoverished by the malignant presence of the CTG can also experience the sustainable growth being enjoyed by communities who were able to expel them;

“WHEREAS, the Municipality of Bulalacao is located at the southernmost tip of the Province of Oriental Mindoro, for the longest time it has been a hotbed for communist insurgency that the government are struggling to defeat and fully destroy;

"WHEREAS, last year, Bulalacao received PhP85,000,000.00 from the NTF-ELCAC that had been used for the construction and improvement of various infrastructure projects and development programs which have been also a part of the counter-insurgency in conveying awareness to people showing that the Government is focused in giving welfare and development in the countryside helping them achieve their goals and aspirations for their families and society as a whole;

"WHEREAS, the Local Government of Bulalacao extremely supports the mission of NTF-ELCAC to disencumber the country from this menace, and finally end the decades long thievery, mass murder, terrorism and economic sabotage being done by the CTG and pay no heed to the voices of their front organizations;
