**RESOLUTION REQUESTING THE ORIENTAL MINDORO ELECTRIC COOPERATIVE, INC. (ORMECO) THRU ROMANBUL DISTRICT SUPERVISOR ENGR. FRANCIS MACALINTAL TO INSTALL ELECTRICAL CONNECTION TO DIVERSION ROAD CROSSING BARANGAY CAMPAASAN AND BARANGAY POBLACION BOTH IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

“WHEREAS, for over the past decades, our Government has always been prioritizing the rural electrification, it strongly believes that the provision of electric services will produce more opportunities to improve the socio-economic growth of the marginalized sectors, and it will have a greater access to basic services and better infrastructure for rural development;

“WHEREAS, the Oriental Mindoro Electric Cooperative, Inc. (ORMECO) is an electric distribution cooperative that concentrates in giving power distribution and efficient consumer services for the entire Province of Oriental Mindoro, also throughout the decades it maintained the Category A Large level status based on the extent and volume of operations as compared with other electric cooperative in the country;

“WHEREAS, Bulalacao is a third class municipality located at the southernmost tip of the Province of Oriental Mindoro, it has a Municipal Government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

“WHEREAS, Bulalacao has a new diversion road crossing its two barangays that helps vehicles especially the huge ones traversing alternative route, the number of households along the area is increasing and there are also infrastructures that are developing such as the new community hospital and evacuation center where electrical supply is indispensable;
