RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 21-T-00003, FY 2022 ANNUAL BUDGET OF BARANGAY BALATASAN, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF FOUR MILLION SIX HUNDRED SEVENTY-THREE THOUSAND EIGHT HUNDRED NINETY-FOUR PESOS (PHP4,673,894.00) OPERATIVE IN ITS ENTIRETY

“WHEREAS, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

“WHEREAS, the Sangguniang Barangay of Balatasan, Bulalacao, Oriental Mindoro submitted its FY 2022 Annual Budget showing therein the sources of income and object of expenditures to this Sanggunian for review on August 3, 2022 pursuant to the provisions of Republic Act (R.A.) No. 7160 which has subjected to following conditions:

- Appropriation for the Gender and Development should not be less than PhP233,694.70.
- Appropriation for the Senior Citizen and PWD should not be less than PhP46,738.94.
- Appropriation for the PPAs for the Local Council for the Protection of Children should not be less than PhP44,148.94.

"WHEREAS, the FY 2022 Annual Budget of Barangay Balatasan was duly taken by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session on August 15, 2022 and was found to be consistent with pertinent laws, rules and regulations;

"WHEREAS, the Sangguniang Barangay of Balatasan, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter which became integral part of this resolution;











