RESOLUTION NO. 20-09-419

RESOLUTION REQUESTING THE SCHOOLS DIVISION OF ORIENTAL MINDORO THRU MADAME SUSANNA M. BAUTISTA TO ALLOW THE CONDUCT OF SMALL GROUP LEARNING/TEACHING ACTIVITIES WITHIN BULALACAO DISTRICT

"WHEREAS, pursuant to Republic Act No. 9155 also known as the Governance of Basic Education Act, the Department of Education (DepEd) was vested with the authority, accountability and responsibility of ensuring access, promoting equity, and improving the quality of basic education;

"WHEREAS, Section 9 of DepEd Order No. 3 s. 2016 states that the Registry of Qualified Applicants refers to the official list of applicants who obtained an overall score of seventy (70) points and above based on the criteria and as result of the evaluation and selection process set herein;

"WHEREAS, because our country is under a state of public health emergency due to COVID-19 pandemic, DepEd was directed to avoid the traditional face-to-face learning in classroom and to adopt new learning delivery modalities where there will be orientations, delivery of learning resources and on-line discussions;

"WHEREAS, Bulalacao, a third class municipality located at the southernmost tip of Oriental Mindoro with a population of 39,107 based on 2015 census, 25 percent of which are indigenous people called Hanunuo Mangyan, has a municipal government that promotes, upholds, and supports "Education for All" advocacy;

"WHEREAS, this Sanggunian advocates for the holding of small group (composed of 3 to 5 pupils/students) learning/teaching activities that would benefit learners specially those who are in geographically isolated and depressed areas;

"WHEREAS, passers of the Licensure Examination for Teachers (LET) who are not yet holders of permanent teaching positions shall be tapped to facilitate or implement this project and DepEd – Division of Oriental Mindoro is hereby requested to give credit to such services by issuing certificates of service actually rendered that can be used by these licensed professional teachers when they seek inclusion in the registry of qualified applicants;

"WHEREAS, every teacher could have a maximum of two (2) groups to be visited once a week and that necessary health protocols must be strictly observed and complied with;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To; request the Schools Division of Oriental Mindoro thru Madame Susanna M. Bautista to allow the conduct of small group learning/teaching activities within Bulalacao District.
