RESOLUTION NO. 20-09-386

RESOLUTION DECLARING THE RESOLUTION NO. 2019-09-5, SANGGUNIANG KABATAAN ANNUAL BUDGET FOR FY 2020 OF BARANGAY SAN JUAN, BULALACAO, ORIENTAL MINDORO ENTITLED "RESOLUTION APPROPRIATING THE SUM OF FOUR HUNDRED EIGHT THOUSAND SEVEN HUNDRED THIRTY SIX PESOS AND FIFTY THREE CENTAVOS (PHP408,736.53) TAKEN FROM TEN PERCENT (10%) OF THE GENERAL FUND OF THE BARANGAY, FOR 10% SANGGUNIANG KABATAAN FUND OF BARANGAY SAN JUAN, BULALACAO, ORIENTAL MINDORO" OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

"WHEREAS, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, Section 329 of the same law states that ten percent (10%) of the general fund of the barangay shall be set aside for the Sangguniang Kabataan and use of such fund shall be in accordance with the Annual Barangay Youth Investment Program and in compliance with the provisions of RA 10742 or the SK Reform Act of 2015;

"WHEREAS, the Sangguniang Kabataan Annual Budget for FY 2020 of Barangay San Juan was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on September 1, 2020 and was found to be consistent with pertinent laws, rules and regulations;

"WHEREAS, Sangguniang Kabataan of Barangay San Juan, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the review letter attached which became integral part of this resolution;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies, Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED To: Declare the Resolution No. 2019-09-5, Sangguniang Kabataan Annual Budget for FY 2020 of Barangay San Juan, Bulalacao, Oriental Mindoro entitled "Resolution appropriating the sum of four hundred eight thousand seven hundred thirty six pesos and fifty three centavos (PhP408,736.53) taken from ten percent (10%) of the General Fund of the barangay, for 10% Sangguniang Kabataan Fund of Barangay San Juan, Bulalacao, Oriental Mindoro" **OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS** reflected in the review letter of the Local Finance Committee;
