**EARNESTLY REQUESTING THE PHILIPPINE COCONUT AUTHORITY (PCA) TO GRANT FINANCIAL ASSISTANCE FOR THE COCONUT FARMERS OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**"WHEREAS**, Bulalacao, a 3<sup>rd</sup> class municipality is a vast agricultural land, has 15 barangays where some are home to indigenous people called Hanunuo-Mangyans, has a total agricultural land area of 10,325.80 hectares where 6,016 individuals are employed in the agricultural sector;

**"WHEREAS**, coconut industry is one of the means of income and livelihood of the people in certain barangays of Bulalacao where there are associations and/or cooperatives that provide services and support economic development of the coconut farmers such as the Samahan ng mga Magsasaka, Mangingisda, Magniniyog ng Bulalacao (SAMMMMBU) and the Campaasan Farmers, Cocoplanters and Livestock Association (CAFACOLA);

**"WHEREAS**, in view of the fact that pandemic has affected the earnings of the coconut farmers of the said municipality, it is adequate to provide financial assistance that would support them in recovering from all the expenses incurred and would somehow redeem their enthusiasm to continue planting and help the stability of coconut supply in the market; Now, therefore, be it...


