“WHEREAS, the Municipality of Bulalacao is one of the coastal municipalities of the Province of Oriental Mindoro whose residents depend on fishing as their main source of income;

“WHEREAS, taking into consideration the immediate environs adjacent to the Municipal Fish Landing Port are filled with houses and small cottage industries in addition to the establishment of various business and tourism infrastructural facilities for Bulalacao is emerging into an agro-tourism hub of Oriental Mindoro;

“WHEREAS, the lives and properties are exposed to danger particularly during the onslaught of bad weather condition as the combined force of currents and waves may erode the shorelines resulting to great sense of loss and devastation;

“WHEREAS, as a preventive measure, a seawall was constructed several years ago to protect the beautiful seashore but likewise to avoid the dislocation of our people from their main source of living that after sometime, this seawall was gradually damaged than an immediate rehabilitation is direly needed; Now, therefore, be it






