## RESOLUTION NO. 17-01-006

**RESOLUTION APPROVING THE ACQUISITION OF 1-UNIT BRAND NEW PASSENGER VAN (SERVICE VEHICLE) TO BE EXCLUSIVELY USED BY THE OFFICE OF THE SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO IN ITS SPECIAL FUNCTIONS AS AN AUGUST BODY**

**"WHEREAS**, pursuant to Section 447 of the Local Government Code of 1991, the Sangguniang Bayan as the Legislative Body of the Municipality shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the Municipality and its inhabitants;

**"WHEREAS**, the Sanggunian powers and functions are categorized into six important concerns; those needed for efficient and effective municipal governance such as the power to approve and pass ordinances and resolutions, those needed to generate and maximize the use of resources and revenues for the development of the Municipality, those needed to tax or regulate business activities, those needed to regulate the use of lands, buildings and structures, those needed to ensure efficient and effective delivery of basic services and facilities and those imposed on it by law or ordinances;

**"WHEREAS**, taking into consideration the abovementioned multifarious tasks assigned and as expected from the Sangguniang Bayan, there is a need to provide them appropriate trainings and seminars from legitimate agencies to enhance their knowledge and skills for the best performance of their duties and functions;

**"WHEREAS**, the Municipal Government of Bulalacao has allocated the amount of One Million Seven Hundred Thousand Pesos (PhP1.7M) in its

Annual Budget for Fiscal Year 2017 to be used for the acquisition of 1-unit passenger van for the Sangguniang Bayan of Bulalacao, with the following specifications:

Engine Type : 3.0L Diesel, 4- Cylinder in Line  
16-V, DOHC (Turbo Charged with VNT) with Intercooler, Euro 4 Emission Control  
Engine Displacement : 2,982cc  
Maximum Output : 100Ps/3,400Rpm  
Type : Passenger Van  
Purpose of Deployment : Service

**"WHEREAS**, the provision of a passenger van to the Sanggunian is believed to be practical and economical for all the eleven (11) members of the August Body including the staff could be well accommodated during their travel to Calapan City or to any place to attend to trainings and seminars; Now, therefore, be it
