RESOLUTION SEEKING CLARIFICATIONS AND FURTHER UNDERSTANDING REGARDING SECTION II OF NCIP ADMINISTRATIVE ORDER NO. 001 SERIES OF 2009 ENTITLED "TERM OF AND REMOVAL FROM OFFICE" OF MANDATORY REPRESENTATION OF INDIGENOUS PEOPLES IN THE LOCAL LEGISLATIVE COUNCIL

"WHEREAS, Section II of NCIP Administrative Order No. 001, series of 2009 entitled "Term of and Removal from Office" clearly states that the term of office of the IP's mandatory representative in the local legislative councils shall be for a period of three (3) years from the date of assumption to office and can be re-indorsed for another term by the ICCs/IPs constituents but in no case shall be the representative serve for more than three (3) consecutive terms. The IPs mandatory representative can be replaced anytime by the ICCs/IPs who selected him/her to the position in accordance with their local guidelines on recall/removal from office;

"WHEREAS, Honorable Tulay M. Caring, the IPMR of the Sangguniang Bayan of Bulalacao, Oriental Mindoro assumed to office on July 1, 2015 which will end on June 30, 2018 pursuant to the guidelines mentioned above however, on July 30, 2018, the NCIP, Bulalacao Service Center chaired by Mr. Romeo M. Morente, CDO III through his letter dated July 30, 2018 to the Regional Director, Roberto L. Almonte, CESO III informed and furnished that office an endorsement letter supported by pertinent documents for the IPMR to stay until the completion and final formulation of the local guidelines to be adopted by the concerned ICCs/IPs in the selection process;

"WHEREAS, last November 2018, Hon. Tulay M. Caring, IPMR, Sangguniang Bayan of Bulalacao, Oriental Mindoro was deleted in the municipal payroll for according to the Municipal Accountant, somebody called her through phone that his term as IPMR representative ended last June 30, 2018, so that upon knowing this, Hon. Caring stop attending session of the Sanggunian;

"WHEREAS, the Sangguniang Bayan of Bulalacao, Oriental Mindoro would like to be clarified on the real status of Hon. Caring based on NCIP rules and regulations because he joined the office with proper documents and it is therefore important that he shall leave with proper information, guidelines and legal basis as well; **Now, therefore, be it**
