### RESOLUTION NO. 20-05-264

RESOLUTION REQUESTING THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT THRU SECRETARY EDUARDO M. AÑO TO FAVORABLY CONSIDER, ALLOW, OR UNDERTAKE THE NECESSARY ADJUSTMENTS IN THE IMPLEMENTATION OF THE CONDITIONAL MATCHING GRANT TO PROVINCES (CMGP) PROJECT IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

“WHEREAS, the Conditional Matching Grant to Provinces (CGMP) for Road Repair, Rehabilitation, and Improvement is a partnership program between the Department of Interior and Local Government (DILG) and Department of Budget and Management (DBM) for provincial local government units in response to the needed infrastructure support, as well as reforms in local roads management and public financial management. It is designed to contribute to a robust and competitive national economy and aims to improve the state of local roads and connect these to national road networks, thus it will enhance local and regional productivity easing out value chain bottlenecks in agriculture, tourism and manufacturing;

“WHEREAS, Bulalacao, a 3<sup>rd</sup> class municipality with a population of 39,107 based on 2015 census, has been granted with a road construction project under CMGP that will traverse Sinarayan, San Juan; Bagacay, Nasucob; San Vicente, San Juan; San Juan Proper; Bangkal, San Juan; and San Roque Proper, construction of which shall commence from Sinarayan;

“WHEREAS, the proposed amount for such project was one hundred eighty million pesos (PhP 180,000,000.00), however, due to circumstances beyond our control the project was approved with the amount of forty six million pesos (PhP 46,000,000.00) thereby making it impossible to complete the concreting works from Sinarayan to San Roque Proper;

"WHEREAS, Sinarayan to Bagacay section has no existing all-weather road, with only few houses, and limited number of users in contrast to San Roque to Bangkal to San Juan Proper to San Vicente sections which have all-weather roads with many users including fishermen, farmers, and tourists who visit Saguicay Island and other nearby tourist destinations;

"WHEREAS, the construction of a box culvert along San Roque to Bangkal section particularly at Piri must be a part of the project and it entails more or less two million pesos (PhP 2,000,000.00) fund;

"WHEREAS, the project must also include construction of slope protection along zigzag sections and construction of drainage canal;

"WHEREAS, based on the foregoing, the LGU of Bulalacao hereby proposes the following adjustments: inclusion of the construction of Piri box culvert in the project; appropriating additional fund in the amount of one hundred million pesos (PhP 100,000,000.00) for the completion of concreting works, construction of slope protection along zigzag portions, and constructions of drainage canal; and transfer of project starting point from Sinarayan section to San Roque section;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, TO; Request the Department of Interior and Local Government thru Secretary Eduardo M. Año to favorably consider, allow, or undertake the necessary adjustments in the implementation of the Conditional Matching Grant to Provinces project in the municipality of Bulalacao, Oriental Mindoro.
