RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2021-09-04, FY 2022 ANNUAL BUDGET OF BARANGAY SAN ISIDRO, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF TWO MILLION FIVE HUNDRED SEVENTY THOUSAND THREE HUNDRED THIRTY-NINE PESOS (PHP2,570,339.00) OPERATIVE IN ITS ENTIRETY

“WHEREAS, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

“WHEREAS, the Sangguniang Barangay of San Isidro, Bulalacao, Oriental Mindoro submitted its Annual Budget for FY 2022 showing therein the sources of income and object of expenditures to this Sanggunian for review on February 15, 2021 pursuant to the provisions of Republic Act (R.A.) No. 7160;

“WHEREAS, the Annual Budget for FY 2022 of Barangay San Isidro was duly taken by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session on March 14, 2022 and was found to be consistent with pertinent laws, rules and regulations;

“WHEREAS, the Sangguniang Barangay of San Isidro, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter which became integral part of this resolution;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies; Now, therefore, be it...
