RESOLUTION NO. 19-08-113

EARNESTLY REQUESTING THE PROVINCIAL DIRECTOR, PHILIPPINE NATIONAL POLICE, PROVINCE OF ORIENTAL MINDORO TO IMMEDIATELY STOP THE OPERATION OF NUMBER GAMES IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, it is the policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living and an improved quality of life for all. It is likewise the policy of the State that the promotion of social justice shall include the commitment to create economic opportunities based on freedom of initiative and self-reliance. Hence, the State hereby condemns the existence of illegal gambling activities such as illegal number games as this has become an influential factor in an individual’s disregard for value of dignified work, perseverance and thief since instant monetary gains from it are being equated to success, thereby becoming a widespread social menace and a source of corruption;

“WHEREAS, gambling is the wagering of money or something of value on an event with an uncertain outcome with the primary intention of winning money or material goods. Gambling thus requires three elements to be present, consideration, risk and a prize;

“WHEREAS, studies shown that the negative effects of gambling addiction includes loss of jobs, failed relationships, increased alcohol and drug abuse and poor mental and physical health of individual and his family;

"WHEREAS, in addition to the above, problem gambling has negative impacts to the community such as domestic violence and negligence of family, debt, bankruptcy, fraud, check forgery, eviction, crime and even suicide;

"WHEREAS, towards this end, it is therefore important to adopt applicable measures and policies to stop and eradicate the existence of illegal number games in the municipality to protect its constituents against social and economic devastation; **Now, therefore, be it**


