RESOLUTION NO. 20-03-240

REQUESTING THE NATIONAL ANTI-POVERTY COMMISSION (NAPC) THRU SECRETARY NOEL K. FELONGCO TO PRIORITIZE BULALACAO, ORIENTAL MINDORO IN ITS PROGRAMS AND SERVICES LIKE THE VILLAGE ECO-GOVERNANCE DEVELOPMENT FRAMEWORK, SAMBAYANIHAN SERBISYONG SAMBAYANAN (3S) AND COOP'ORATION

"WHEREAS, the Republic Act 8425 institutionalizes the government 's Social Reform Agenda (SRA), which enjoins National Anti-Poverty Commission (NAPC) to strengthen and invigorate the partnerships between the national government and the basic sectors, through a systematic package of social intervention, the state hopes to ensure that social reform is a continues process that addresses the basic inequities in Philippine society and that a policy environment conducive to social reform is actively pursued;

"WHEREAS, the National Anti-Poverty Commission is a government agency of the Republic of the Philippines; it coordinates poverty reduction programs by national and local governments and ensures that marginalized sectors participate in government decision-making processes, it mandates to strengthen Local Government Units so they can incorporate the Social Reform Agenda in their local development effort of the Philippines;

"WHEREAS, the Municipality of Bulalacao is a 3rd class municipality located at the southernmost tip of the Province of Oriental Mindoro and pursuant to the 2015 census it has population of 39, 109 people where a large number of it are necessitous including the indigenous people called Hanunuo-Mangyans;

"WHEREAS, it is evident that the Municipality of Bulalacao, Province of Oriental Mindoro is still experiencing scarcity on employment and working opportunity which made the residents suffer into poverty, it will be benignant to this Municipality to have program and services catered by NAPC like Village Eco-Governance Development Framework, Sambayanihan Serbisyong Sambayanan (3S) and Coop'poration that will certainly provide and support the livelihood of its residents; **Now, therefore, be it**
