EARNESTLY REQUESTING MR. ELIZER S. SALILIG, MFI, OIC-REGIONAL DIRECTOR, BFAR, REGION IV-MIMAROPA TO ALLOCATE THE NECESSARY FUNDS TO BE USED FOR THE PURCHASE OF ONE (1) UNIT OF SPEED BOAT FOR THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, the Municipality of Bulalacao has the biggest municipal waters in the whole Province of Oriental Mindoro consisting of approximately 58,000 hectares of fishing ground providing large volume of aqua marine products particularly fish of various species transported to nearby municipalities and provinces;

“WHEREAS, to protect its fishing ground against illegal fishing, there were three (3) fish sanctuaries established and maintained by the Local Government Unit to conserve and enhance aquatic biodiversity, restoration and conservation of marine habitat, and increase fish production to achieve, improve and sustainable fishing industry;

“WHEREAS, equally important is the availability of speed boat to be used for seaborne patrolling by the Bantay Dagat personnel and workers to ensure the enforcement of pertinent fishery laws and ordinances; **Now, therefore, be it**






