## RESOLUTION NO. 19-07-086

### RESOLUTION EXPRESSING STRONG SUPPORT TO SENATE BILL 136 ENTITLED MAGNA CARTA FOR BARANGAYS INTRODUCED BY SENATOR JUAN EDGARDO M. ANGARA

**“WHEREAS**, Section 384 of the R.A. 7160 otherwise known as the Local Government Code of 1991 states that the barangay as the basic political unit serves as the primary planning and implementing unit of government policies, plans, programs, projects and activities in the community, and as a forum wherein the collective views of the people may be expressed, crystallized and considered and where disputes may be amicably settled;

**“WHEREAS**, given the important role the barangay performs Senate Bill No. 136 to be known as the Magna Carta for Barangays intends to help barangays better perform their mandate of delivering basic services and facilities to their respective communities in the most efficient, responsive and sustainable manner;

**“WHEREAS**, the proposed Magna Carta for Barangays also seeks to recognize barangay officials as regular government employees with fixed salaries, allowances, insurance, medical and dental coverage, retirement benefits and such other fringe benefits for which a regular employee may be entitled to instead of just receiving honoraria;

**“WHEREAS**, Senate Bill No. 136 also proposes to promote the welfare of the barangays by providing them appropriate basic services and facilities such as regular supply of clean and potable water, public transportation, schools, health centers and barangay halls in order to meet the requirements of their populace. It will ensure that barangays enjoy genuine and meaningful local autonomy and attain full development such as automated release of their shares from national taxes, transfer of funds to barangays for the maintenance of roads and bridges, mandatory shares in taxes, fees and other charges and priority in employment;

**“WHEREAS**, in view of the foregoing, the Sangguniang Bayan of Bulalacao, Oriental Mindoro strongly supports Senate Bill No. 136 entitled “Magna Carta for Barangays”; **Now, therefore, be it**


