RESOLUTION REQUESTING THE ORMECO TO INSTALL ELECTRICAL CONNECTION TO NEWLY OPENED EXTENSION SCHOOLS IN THE MUNICIPALITY OF BULALACAO

WHEREAS, pursuant to Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, pursuant to Executive Order No. 370 the Municipality of Bulalacao is considered as a 3rd class municipality; it is located at the southernmost tip of the Province of Oriental Mindoro, the updated number of schools within the municipality are 46 elementary schools including extensions and 22 high schools including extensions;

WHEREAS, the Oriental Mindoro Electric Cooperative, Inc. (ORMECO) is an electric distribution cooperative that concentrates in giving power distribution and efficient consumer services for the entire province of Oriental Mindoro, also throughout the decades it maintained the Category A Large level status based on the extent and volume of operations as compared with other electric cooperative in the country;

WHEREAS, the newly opened extensions for both elementary and high schools of the Municipality of Bulalacao namely Waring Elementary School, Agong Elementary School, Gatol Elementary School, Cambunang Elementary School, RVD-GK Elementary School, Kalatas Elementary School, Bagong Sikat High School, Milagrosa High School, Namalayan High School, Libtong High School, Waring High School, Umabang High School, Tambangan High School, San Isidro High School and Balatasan High School are in dire need of electric connection, this will be beneficial to the teachers, school personnel and more importantly to the students, Now, therefore, be it;

RESOLVED AS IT IS HEREBY RESOLVED, To; Request the ORMECO to install electrical connection to newly opened extension schools in the Municipality of Bulalacao.
